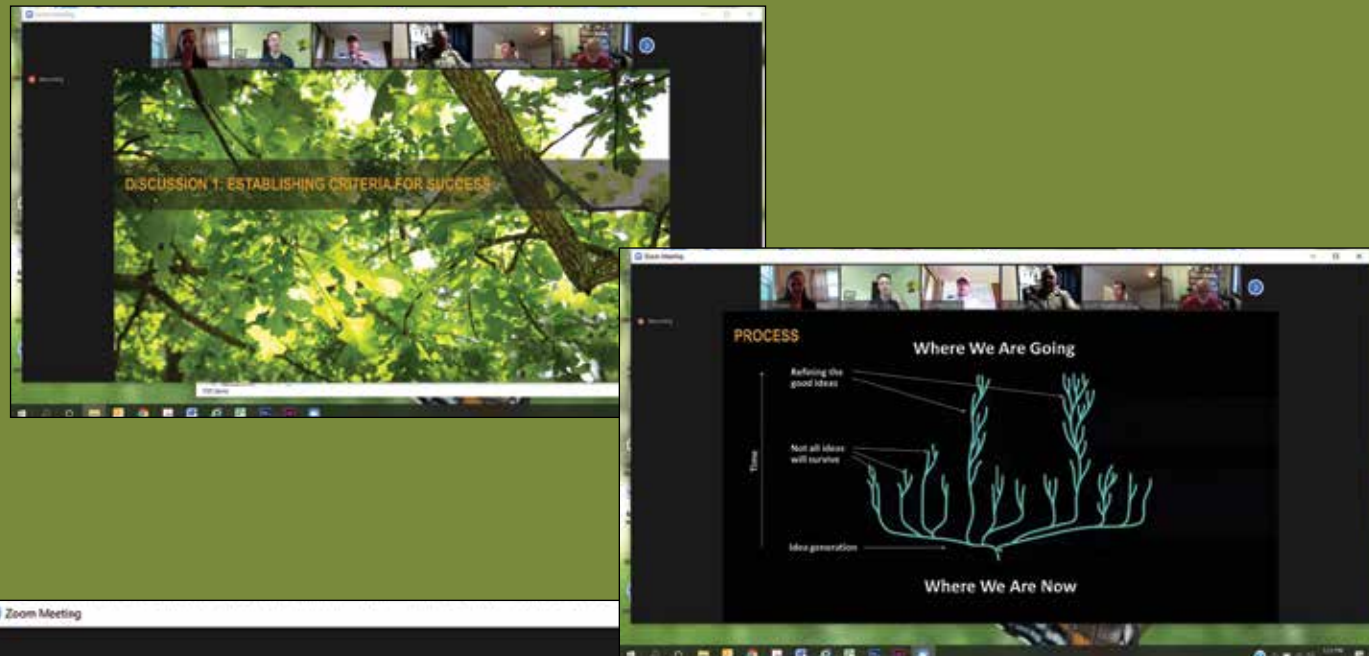

PROTECTING What You Love



In 2018, we began a year-long process to review and revise the Forest Preserves' Strategic Plan. Many of you took the time to tell us what you love about your preserves and where we should focus our resources over the next five years. Here is what we learned from you:

- Lake of the Woods is the most visited preserve, with Homer Lake not far behind
- Many more of you have discovered Middle Fork River Forest Preserve over the last six years
- Nearly one-third of you visit a preserve more than once a week

- Spending time in nature is the number one reason you choose to visit, but almost as many of you also enjoy hiking or running on the trails
- You strongly agree that the forest preserves provide environmental benefits like clean air, clean water, and protection of the Mahomet aquifer
- The forest preserves offer a connection to nature that is very important for you and your family
- A large majority (86%) of you emphasized the need for us to maintain our existing preserves, facilities, and buildings

In the fall of last year, the Forest Preserve's Board of Commissioners adopted a new Strategic Plan, for the years 2020 through 2024.

To Meet the Forest Preserves' Needs and Your Expectations...WE NEED YOUR HELP

The Forest Preserve's property tax rate has remained substantially unchanged in forty years, attesting to our outstanding stewardship of taxpayers' money. But our buildings, roads, dams, bridges, lakes, and shelters are aging, and 1980 revenue can't keep up with 2020 costs.

The Champaign County Forest Preserves' Board of Commissioners will discuss asking voters for a very small property tax limiting rate increase, among other options, to meet our capital and operating needs.
