## **NEW BUSINESS**

### A. Board NRPA Travel

Commissioner Herakovich moved the Board approve \$2,157.19 for 2022 NRPA Conference travel expenses for Commissioner Andrew Kerins. This includes a \$189.19 transportation allowance overage from the last updated travel expense policy approved in 2016. Commissioner Hays seconded. A roll call vote was taken. The following commissioners voted "yes": Goodman, Hays, Herakovich and Kerins.

#### B. Purchase of ADA Lift for HQ Basement

Commissioner Herakovich moved the Board approve the bid for an ADA lift (Materials and Installation) at Lake of the Woods Forest Preserve from CCM Champaign County Mobility for Twenty-Nine Thousand Nine Hundred Seventy-Eight dollars and 00/100 (\$29,978.00) and authorize the Executive Director to execute the contract. Commissioner Kerins seconded. Commissioners confirmed the unit was within fire code. District Planner, Bridgette Moen, advised the unit did meet fire codes. A roll call vote was taken. The following commissioners voted "yes": Goodman, Hays, Herakovich and Kerins.

### C. Purchase of HVAC for HQ Basement

Commissioner Kerins moved the Board the quote for HVAC (Materials and Installation) at Lake of the Woods Forest Preserve from P&P Heating and Cooling for Nineteen Thousand Two Hundred dollars and 00/100 (\$19,200.00) and authorize Executive Director to execute the contract. Commissioners commended staff for repurposing the smaller unit that was in the artifact storage room. A roll call vote was taken. The following commissioners voted "yes": Goodman, Hays, Herakovich and Kerins.

## D. CCFPD and Ogden Intergovernmental Agreement

Commissioner Kerins moved the Board approve the intergovernmental Agreement (IGA) for Kickapoo Rail Trail Maintenance and Trail Upgrade within the Village of Ogden. Commissioner Hays seconded. Deputy Executive Director, Mike Daab, noted the agreement had been recently approved by the Village of Ogden with only one minor change that is not noted in the current version, with that change being in the maintenance section, second sentence will notate that Ogden will not allow grass to reach eight (8) inches or greater in height, not 6" as the current copy states. A roll call vote was taken. The following commissioners voted "yes": Goodman, Hays, Herakovich and Kerins.

# E. Change Order 1 for KRT Phase 2C Ogden Construction

Commissioner Kerins moved the Board approve a change order request for KRT Phase 2 C Ogden project from Stark Excavating for Fifteen Thousand Two Hundred Fifty-Five dollars and 33/100 (\$15,255.33). Commissioner Hays seconded. A roll call vote was taken. The following commissioners voted "yes": Goodman, Hays, Herakovich and Kerins.
