B. O2022-01 Providing for the issue of \$492,729 Taxable General Obligation Limited Tax

Bonds, Series 2022- for the purpose of paying costs of maintaining forest preserve lands and facilities in and for the District and for the payment of the expense's incident thereto, providing for the levy of a direct annual tax to pay the principal and interest on said bonds, and authorizing the sale of said bonds to the Corporate Fund of the District

Commissioner Herakovich moved the Board approve the issuance of \$492,729 Taxable General Obligation Limited Tax Bonds, Series 2022, of the District, for the purpose of paying costs of maintaining forest preserve lands and facilities in and for said District and for the payment of the expenses incident thereto, providing for the levy of a direct annual tax to pay the principal land interest on said bonds, and authorizing the sale of said bonds to the corporate fund of the District. Commissioner Hays seconded. A roll call vote was taken. The following commissioners voted "yes": Goodman, Hays, Herakovich, Kerins, and Livesay.

C. <u>R2022-02 Phase 2C Ogden, Local Public Agency Agreement for Federal Participation – KRT</u> Commissioner Herakovich moved the Board adopt Resolution 2022-02 approving a local public agency agreement (LPA) for the construction engineering and construction of the Kickapoo Rail Trail, from 2650E to 2800E in Ogden, in an amount of \$136,480.00. The project bid will be let by the Illinois Department of Transportation (IDOT). Commissioner Hays seconded. A roll call vote was taken. The following commissioners voted "yes": Goodman, Hays, Herakovich, Kerins, and Livesay.

D. Request to Acquire Collections

Commissioner Herakovich moved the Board approve the request to acquire the following items included in the following offers: IDOT Snowy Owl. Commissioner Livesay seconded. A roll call vote was taken. The following commissioners voted "yes": Goodman, Hays, Herakovich, Kerins, and Livesay.

E. Museum and Education Dept. Strategic Institutional Plan

Commissioner Herakovich moved the Board approve the Museum and Education Strategic Institutional Plan for 2022-2027. Commissioner Hays seconded. Commissioner Herakovich amended her motion to also include **Item F**: Resolution 2022-03: Supporting the Museum of the Grand Prairie, and **Item G**: The Museum and Education Department Ethics Statement. Commissioner Hays seconded. Museum & Education Director, Barb Ohlschlager-Garvey reported the document has been worked on over the past 4 years by staff. Commissioners commended staff on their work on the plan, noting they should be proud of their work on the document, and the high level of professionalism the document shows. Commissioners asked if being accredited helped with obtaining grants. Staff noted there isn't grants that only accredited agencies can obtain, but the accreditation status is helpful. Commissioners suggested a study session be used for future year reviews of the documents. A roll call vote was taken. The following commissioners voted "yes": Goodman, Hays, Herakovich, Kerins, and Livesay.

H. HR2022-04 HR Policy: Temporary Weekly COVID 19 Testing Policy

Commissioner Kerins moved the Board approve Resolution: 2022-04 pertaining to the Districts Temporary COVID-19 Weekly Testing Policy. Commissioner Herakovich seconded. HR Generalist, Dara Edgington, stated due to the high number of positive COVID-19 cases at the District, that staff felt the need to respond to keep the workplace safe. Kerins noted he was happy to see the policy in place. Livesay asked if the test would be administered on site and how often would a review of the policy be performed. Edgington reported staff would be given time during the working shift to get tested locally, and locations in Urbana and Rantoul should assist travel time for Homer Lake and Middle Fork staff; and Pearson noted she would review local COVID-19 data weekly to see if an adjustment needs to be made. A roll call vote was taken. The following commissioners voted "yes": Goodman, Hays, Herakovich, Kerins and Livesay. Motion carried.
